Year End Review



2014 came and went as fast as the year before, but not without its share of incidents that affect our community and ideas that help us make our community a better place to live and visit. Our agency saw the testing and initial implementation of the Body Worn Digital Cameras. While on its face this is a positive move forward, it does not come without struggles with how we find the computer storage space for the high definition video that is produced. Additionally, with the overwhelming request for body worn cameras by agencies across the country, so came the inability of manufacturers to maintain quality control and produce enough for purchase. So we continue to incorporate their use and manage what they produce.

Our Methamphetamine trained team members received the equipment and training needed to make a solid impact at combating this scourge in our community. We are proud to announce that VCSA complaints are down 13%, and Suspected Narcotics activity is down 45%. We have once again teamed with the Eaton County Sheriff Office and the Tri-County Metro Narcotics Squad to develop leads, investigate tips and ultimately arrest and convict those who chose to be involved in drug related crimes.

We have expanded our Internship program with Olivet College and now have an intern each semester throughout the school year. In addition, we have partnered with RESA and encourage high school aged students who are looking to go into the criminal justice profession to come see how the Police Department works. One such student was fortunate enough this year to be with our Detective for a day while we solved a series of burglaries that just occurred within the last week.

Equipment was updated for the department in the area of crash investigation with laser measuring and CAD drawing software and all officers received the up to date smart generation Taser weapons and training.

Facebook and Twitter continue to be a way for us to communicate activities and announcements to the general public. The Police Beat column in the local paper also adds a popular way to give notice and inform the public of incidents being encountered by officers and public safety information to keep the community up to date.

The department was proud to announce that Officer Paul Montague is celebrating his 25th year with the City of Charlotte. His experience and expertise continues to be a valuable asset to our department and community. We also welcomed Officer Douglas Rehard to our group in September. Officer Rehard filled out our last open spot allowing us to be fully staffed at 16 officers. Being fully staffed reflects in our ability to reduce how crime affects our population and how quickly we are able to solve complicated and time consuming investigations.

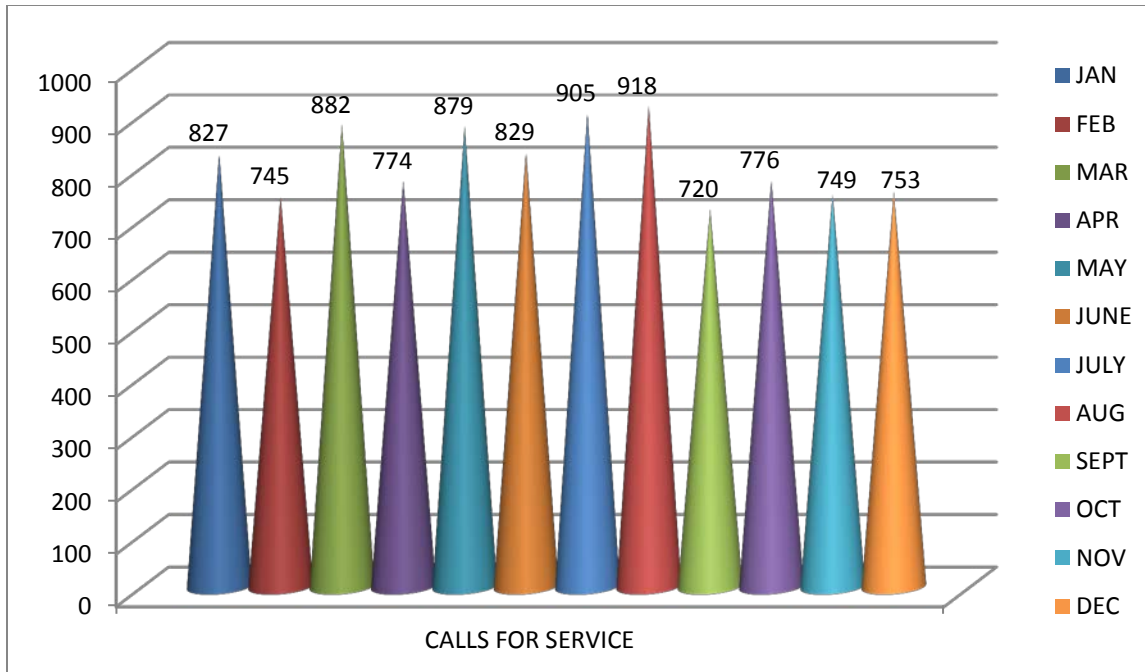
Some key cases that our department investigated during the year involved the Robbery of Pizza Hut, where a career criminal tried to rob the restaurant, ended up getting stabbed in the process and ultimately was apprehended and found guilty of his crime. Thankfully, he will be off our streets for the rest of his life. A motor vehicle fatality involving alcohol was adjudicated this year. Our crash investigation team and Detective bureau worked tirelessly to put together the pieces of the case and see the driver plead guilty to killing a pedestrian as a result of operating while intoxicated. A Second Degree Murder case involving a driver of a vehicle on Packard Highway from 2013 is still awaiting trial. Again our crash investigation team and Detective bureau spent many hours putting together this case for prosecution.

As result of numerous complaints and violations, the Liquor License of CBs Bar was suspended by the Liquor Control Commission. Our department attempted to work with the owner and help them meet compliance, but that effort was futile.

After the State of Michigan implemented a new reporting process for Registered Sex Offenders, our department took a strong position on the record keeping and updating of the Sex Offenders living within our city limits. Each offender must report to our agency in person, update all information directly in front of an investigator and house checks are done to ensure compliance. We are one of the few law enforcement agencies to take this aggressive approach to the documentation and oversight of these individuals. Our Detective division keeps accurate records of offenders and violations and notifies the Prosecutors office immediately of violations in registration and compliance.

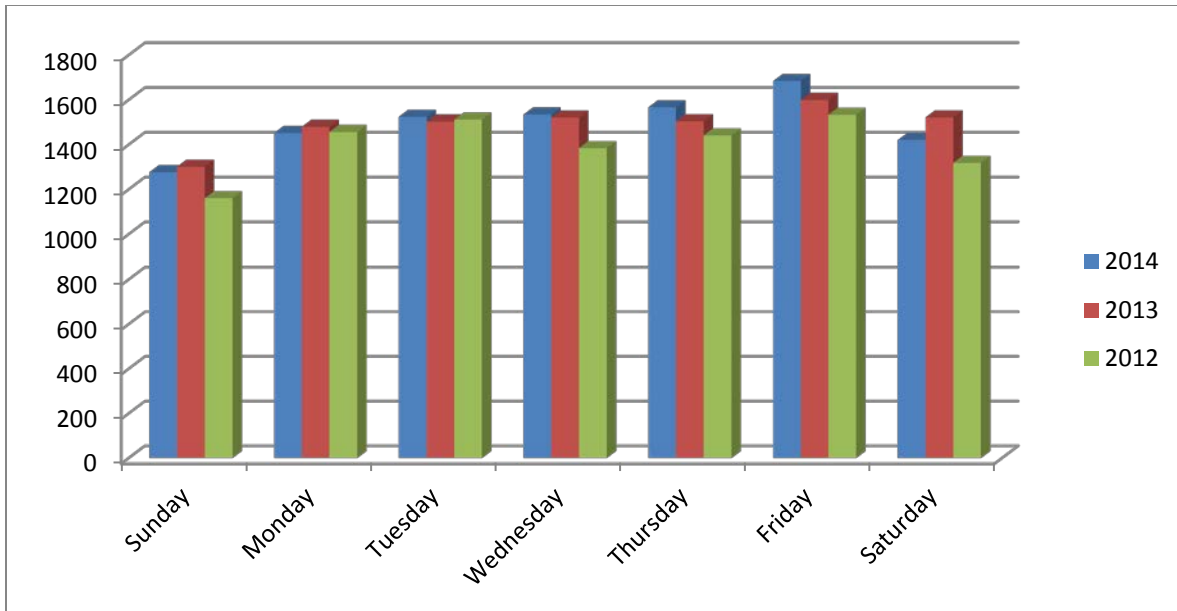

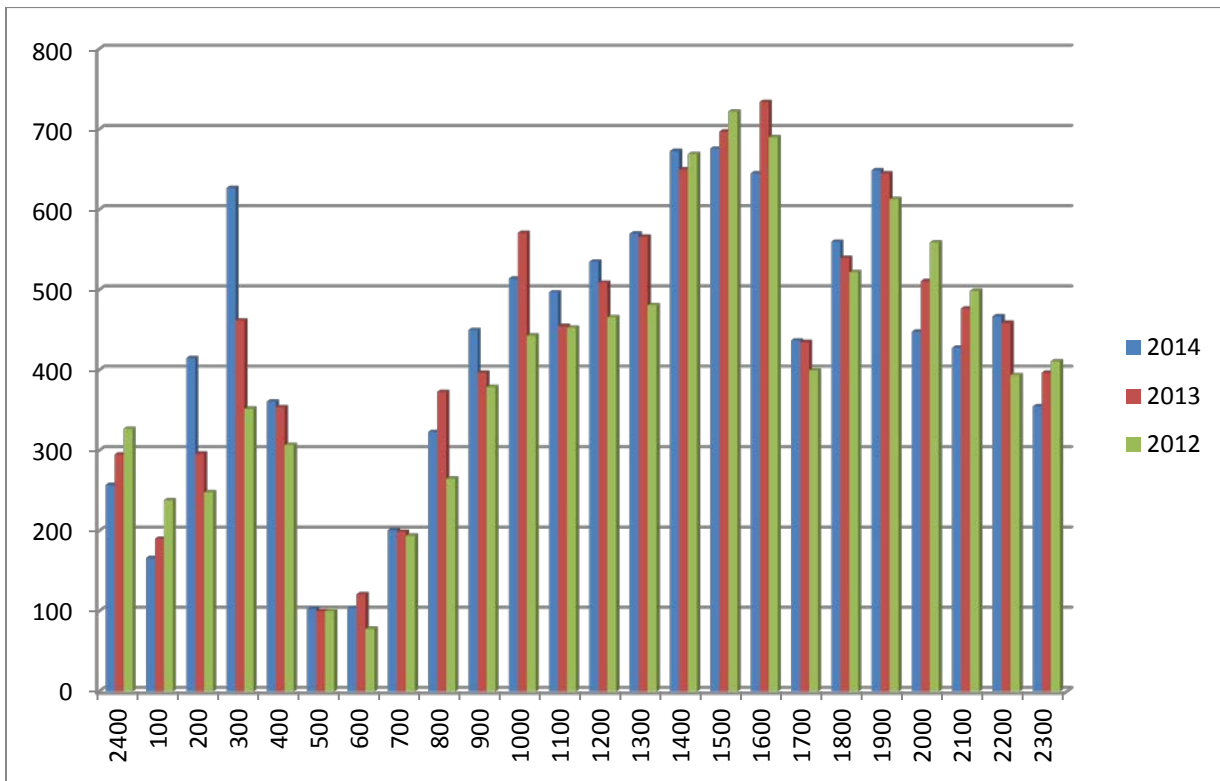

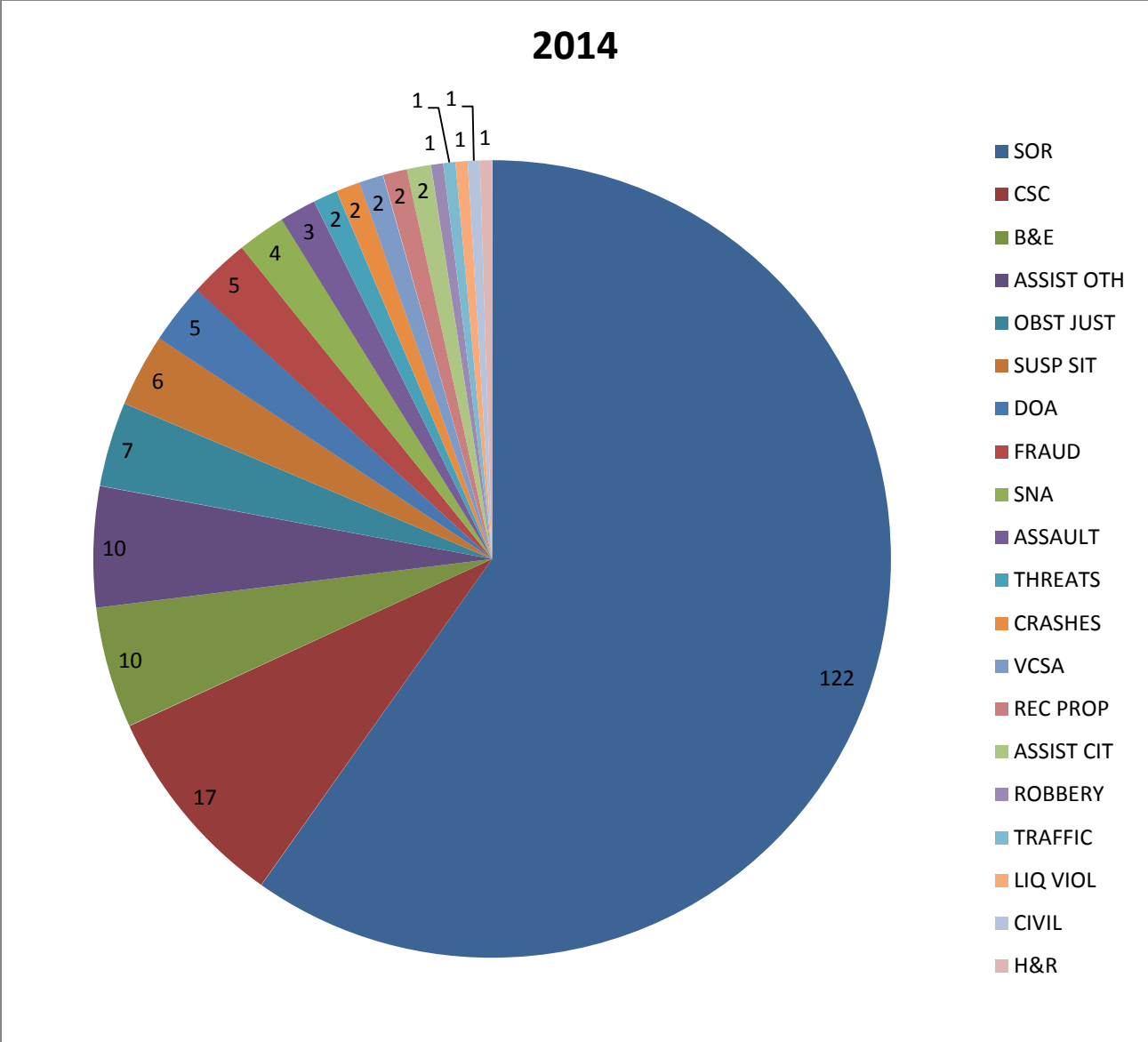




CALLS FOR SERVICE BY DAY OF WEEK

DETECTIVE DIVISION INVESTIGATIONS

In 2014, the Charlotte Police Department Detective Bureau was involved in 197 criminal investigations. This number is up from last year, and the second highest number of cases handled by a single Detective in one years' time. Individual investigations and follow-up can take from three days to three years to resolve depending on the complexity.

With every year, there are always some cases that deserve recognition. Here are just a few of those cases.

14-00331 On 01-13-2014 police responded to a N. Cochran address where a teenage male was barricaded in his home with weapons. This subject had become upset at his parents because they would not buy him drugs, so he proceeded to assault the occupants of the home. During the course of the assaults, this subject came in to the possession of some long guns. The family was able to evacuate the home. CPD was able to talk the suspect out of the house, and the suspect was arrested for Felonious Domestic Assault.

14-01086 On 02-10-2014, Charlotte Police began an investigation involving a 23 year old woman having engaged in sexual intercourse with a 14 year old male. During the course of this investigation, many twists and turns occurred. The 23 year old woman admitted to several sexual encounters with the 14 year old boy. The 14 year old boy admitted that there was one occasion in which he forced himself on to the 23 year old woman, forcing her to have sex with him. Throughout all of this, the 14 year olds mother was found to be providing marijuana to both the boy and woman. All subjects involved in this investigation were charged with crimes.

14-02030 On 03-17-2014, Charlotte Police responded to the VFW to assist EMS with a subject that was found unconscious outside the building. The investigation discovered that the victim had sustained a serious head injury. Many rumors were circulating throughout the community as to how this individual had obtained this injury. Many had suggested that the victim was in this condition as the result of an assault. This lengthy investigation resulted in that this subject was not the victim of an assault, but the victim of too much drinking, falling, and hitting his head on a hand rail. All possibilities of an assault were explored and were all deemed inconsistent with the crime scene and physical evidence.

14-03045 On 04-20-2014, the Charlotte Pizza Hut was robbed. At the time, police only had statements to go on provided by Pizza Hut staff regarding the

suspect's appearance. The investigation resulted in the discovery of the type of vehicle used by the suspect. Officer Poortvliet was observant enough to locate a vehicle that matched the description. A suspect was established and the investigation resulted in the arrest of Bruce Weaver. Weaver was found guilty by a jury of 12, and will most likely be spending the remainder of his life in prison.

14-04891 and 14-04894 On 07-02-2014, two residences were broken in to during the course of the evening. Property taken from one of the residences was pawned in Lansing, and other property was located at two other individuals' homes. Three young adults were found to be responsible for these acts, and all have been charged.

14-05269 On 07-24-2014, CPD began an investigation involving a mother, financially exploiting her special needs, adult daughter. This time consuming case showed that the mother had been removing funds from her daughters account and transferring them to her own account, as well as making several trips to casino's. The mother would not cooperate with the investigation and the case was sent to the prosecutor for their review.

14-07036 On 09-22-2014, an investigation was started on a young woman that had passed away unexpectedly. The investigation showed that she had passed away from a combination of prescription drugs and alcohol consumption. This was a woman who has had this problem for many years and her friends had turned a blind eye to her habits which ultimately claimed her life.

14-07344 On 09-28-2014, a motor vehicle versus bicycle personal injury crash occurred on S. Cochran Ave. At the time, the bicyclist's prognosis was not good, having sustained a brain bleed. The investigation showed that the bicyclist had a motor installed on the bike, causing him to travel faster than what a reasonable person would expect. The motor vehicle had turned on to a side road and the bicyclist was unable to stop or properly pass this vehicle, causing the bicyclist to impact the side of the vehicle. The bicyclist did recover from his injuries and was found at fault for the crash.

14-07446 On 10-02-2014, a piece of a brain was discovered at a local gas station. This organ was collected and analyzed, and was determined to have come from a deer. No further investigation was then needed.

14-08951 During the first week of December, there were a number of churches and businesses that had been broken in to and had items stolen from them. A video of the suspect was made public and several tips started coming in on a number of people. All but one of those people was cleared. The suspect was now known to be staying in Ionia. Contact was made with the Ionia Police, only to discover that they too, have been having churches broken in to. Ionia PD was advised of who our suspect was and where he was staying. The following evening, a church in Ionia was broken in to and officers responded to the suspect's residence where they discovered stolen property in his vehicle. Surveillance was placed on the suspect's home where he was ultimately taken in to custody. This suspect confessed to crimes committed in Ionia and when CPD representatives arrived to interview this suspect, he then admitted to crimes committed in Charlotte. The prosecutor is currently reviewing this case while the suspect remains in custody in Ionia.



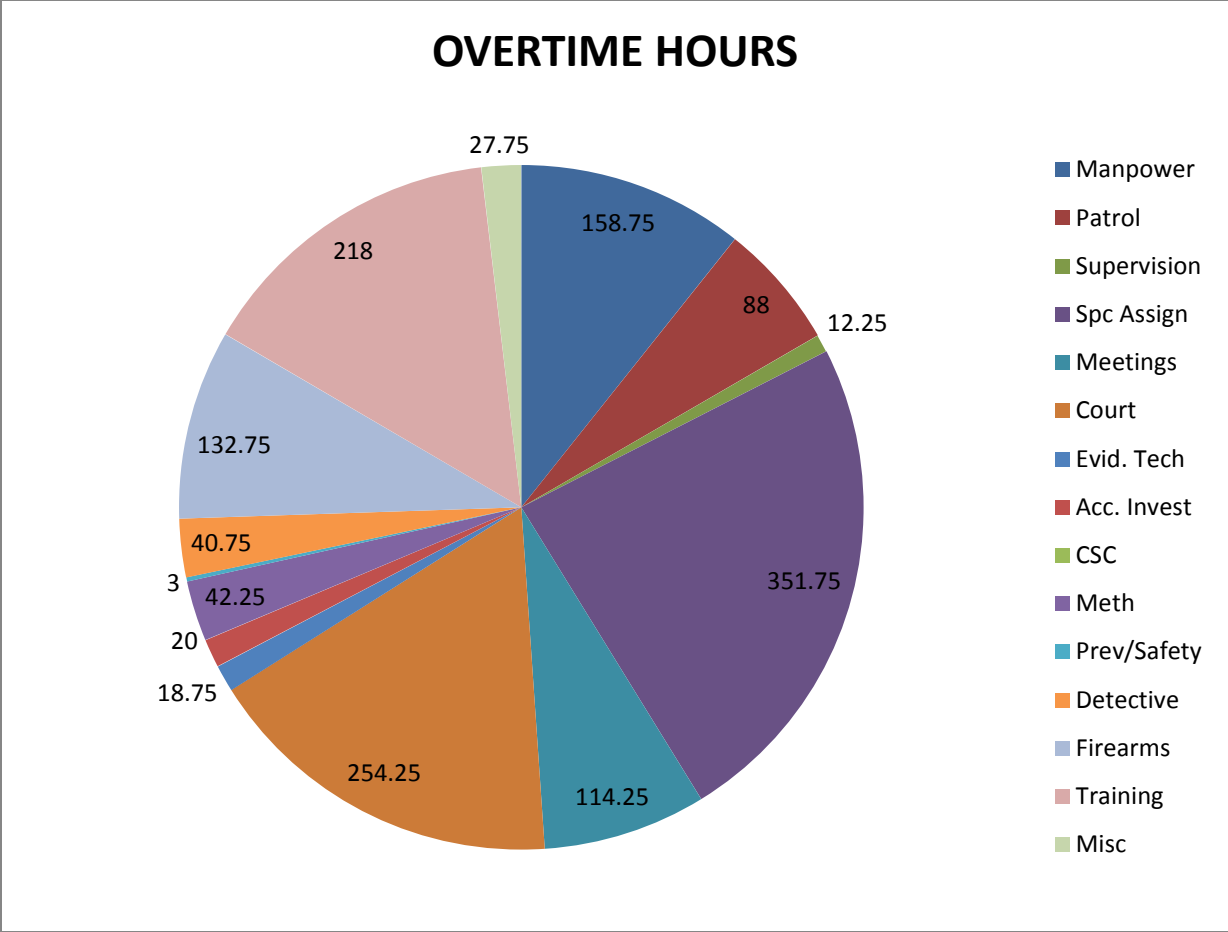

The Special Victim's Unit is currently comprised of three team members. Detective James Beal, Officer Paul Montague, and Officer Justin Bahm. This year, the team was fortunate to acquire Officer Bahm, and will be recruiting additional officers for the specialized training and investigations.

For 2014, investigators handled a total of 158 cases. Of those cases, 21 were for Criminal Sexual Conduct investigations, which is two more than the previous year.

As usual, contact with Registered Sex Offenders topped the list of activity. Currently, there are 44 Registered Sex Offenders residing in the City. This is 18 less than last year. A total of 122 contacts with Sex Offenders occurred in 2014. These contacts consisted primarily of them coming in to our office to either verify, or update information. Some of these contacts involved the failure of some of offenders to comply with the rules they are obligated to follow, and some were from random house checks performed on their residence.

The remaining investigations involved Assisting Other Agencies, Suspicious Situations, Financial Exploitations, Taking Advantage of a Vulnerable Adult, and Obstructing Justice complaints.



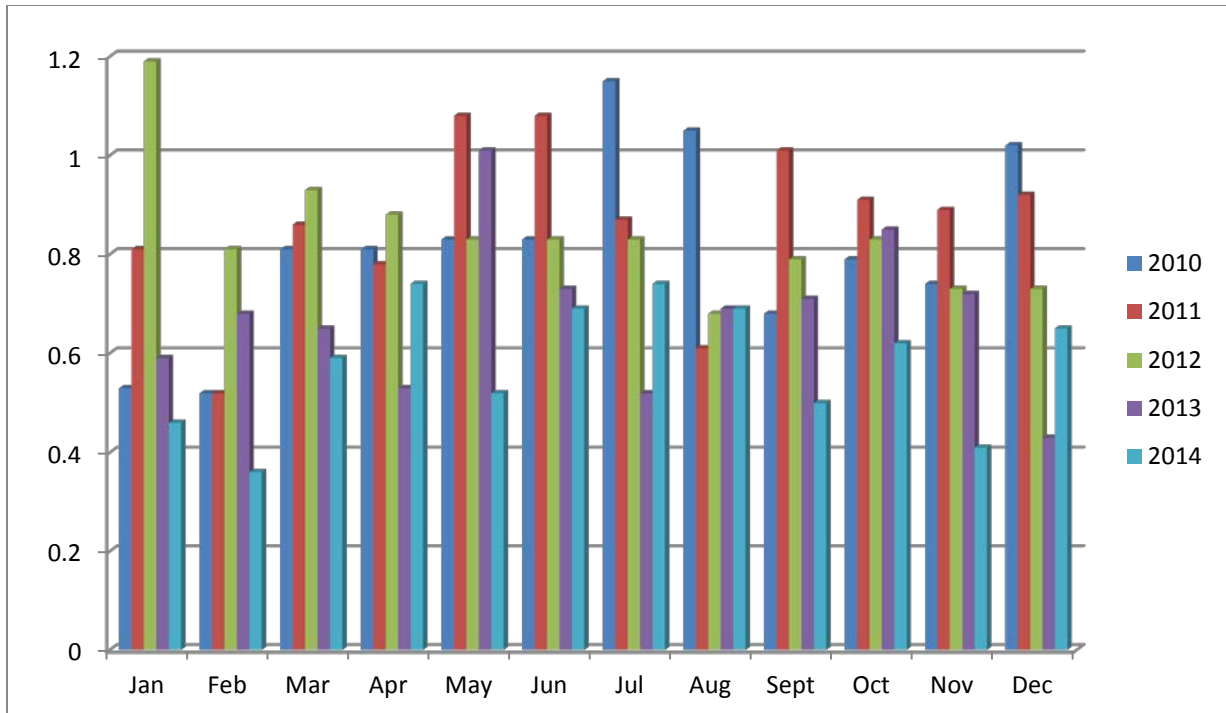
Special assignments and Court appearances comprise the two largest areas that produce overtime by the staff. These are areas those we have little or no control over.

Special assignments are those types of activities such as parades, beer tents, car shows, 5K road runs and sporting events to name a few.

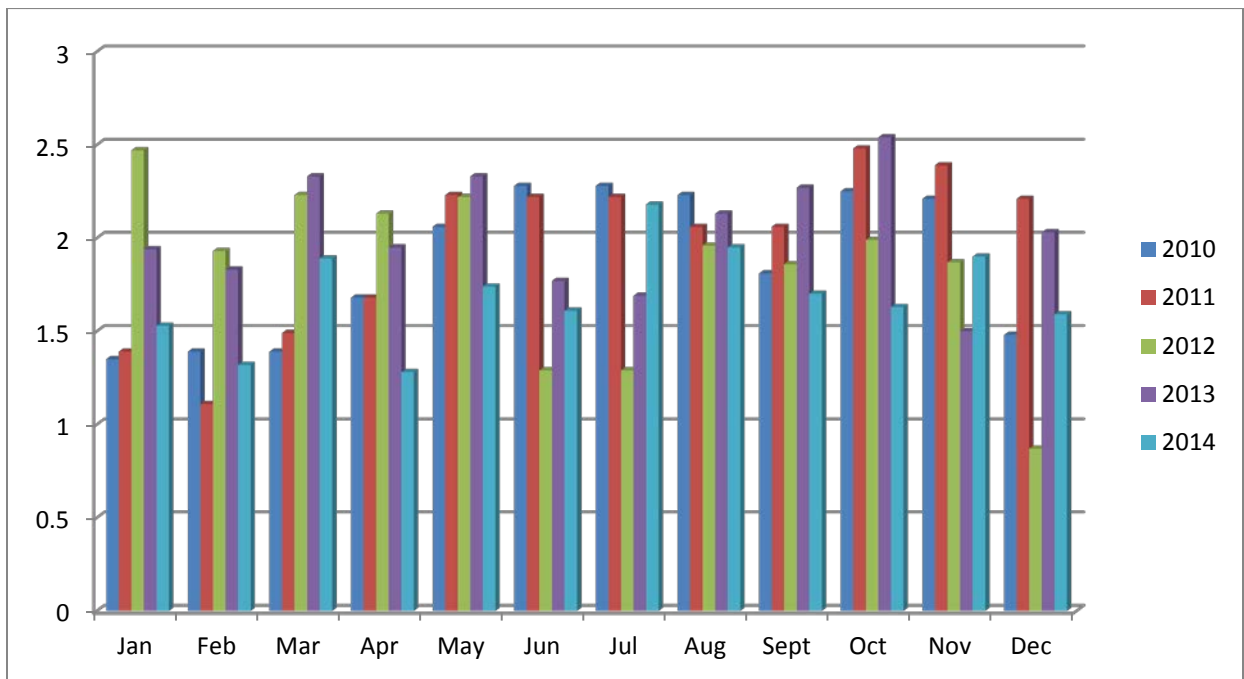
Court cases range from informal traffic hearings to Circuit Court trials. Many pre-trials and trials last several days and involve multiple officers to testify.

The third area that produces overtime for the staff is training. Whether it is mandatory, annual, or re-certifications, training is essential in maintaining a high quality workforce. Much high risk procedure training is mandated by the state and it is not feasible to do with on-duty officers who constantly have to leave to take calls for service and manage the daily requirements of shift work. Training in larger groups allows cohesiveness among the officers so as to minimize the risk of unfamiliarity at high stress times.

The fourth largest area that produces overtime is manpower requirements. Arrest warrant transports, search warrant and high risk entries or arrests, mental health order transports to Lansing hospitals and road coverage for other incidents that require officers to maintain minimum road coverage in the city in order to perform required tasks that take them outside of town for periods of time or investigate larger scale incidents.

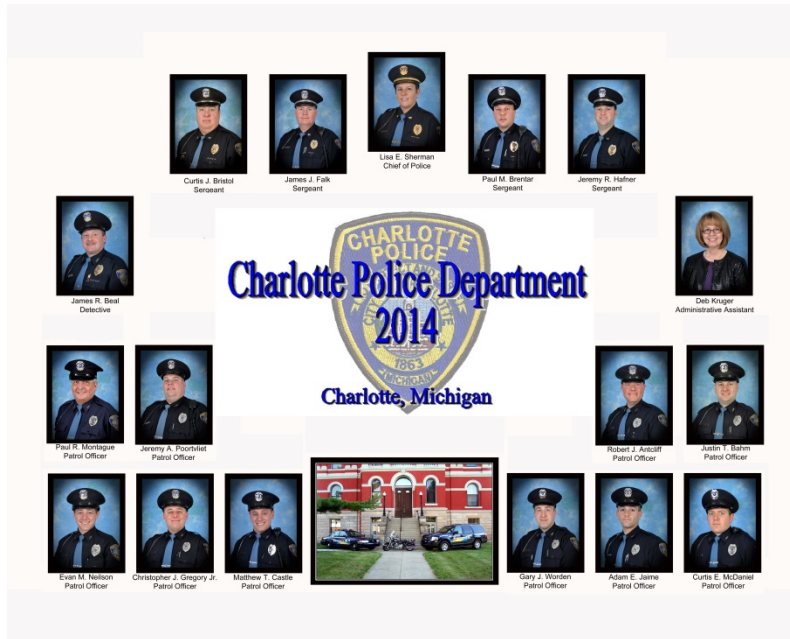
