

# 2014 Annual Report

The Barry-Eaton District Health Department (BEDHD) envisions a future where every resident has the opportunity to live a long, healthy, and active life. How does that future happen? It happens through thoughtful choices at every level — choices by individuals, families, businesses, schools, organizations, and communities to prioritize and take action on health.

Investing in the well-being of communities and making health a priority in comprehensive planning can reduce the number of people overall that get sick, how sick they feel, and if they die early... or live a long time. The purpose of public health is to promote



the health of the population, making sure that people have safe, clean, and healthy places to live, work, and play, and to make sure that diseases and injuries are *prevented* whenever possible.



The BEDHD has made addressing chronic disease an overarching theme of many of its programs and initiatives. We work on four components – **healthy eating, active living, tobacco control, and the built (man-made) environment** to combat the onset and impact of chronic disease. Through our Community Outreach efforts BEDHD professionals regularly attend municipal meetings and community coalitions to foster connec-

- Due to extensive outreach, the Women, Infants, and Children (WIC) caseload increased from 85.6% in December 2013 to 93.4% in December 2014.
- Breastfeeding initiation rates by women enrolled in WIC increased 3%.
- WIC's Breastfeeding Peer Counselor Program increased rates of breastfeeding initiation among new mothers—averaging a 10% increase in the last 3 years.
- Initiated "Pathways to Better Health" which is a home visiting program for individuals enrolled in Medicaid and/or Medicare who have two or more chronic health conditions.
- Referred 594 children for additional vision follow-up.
- Referred 284 children for additional hearing follow-up.
- Breast or cervical cancer screening received by 166 women.
- Two breast cancers were diagnosed and referred for treatment.
- Continued partnership with the MSU School of Nursing to offer students the opportunity to complete a Public Health rotation at the Health Department.
- The Children's Special Health Care Services program was moved to an electronic medical record format.
- In each county, the vaccination rate for uninsured and underinsured children was analyzed, and recommendations were developed to increase healthcare provider participation in immunization programs serving this population.



## Eaton Behavioral Health

- Women's Specialty Program has served four women who have had drug-free births.
- Maintained partnerships with 25 local community partners to best assist our clients.
- Peer Support Services conducted four 36hour training sessions for Peer Lifestyle Coaches.
- Offered 87 group Lunchtime Acupuncture Sessions to the community.
