**Re:** Appointment of Clerk-Treasurer

On the agenda for Council's consideration is a resolution to appoint the current City Clerk, Pearl Tidwell, as the Clerk-Treasurer per the discussion at the February 9<sup>th</sup> study session. The City Charter outlines the offices of Clerk and Treasurer are appointed by the City Manager upon confirmation by City Council. Additionally, she is well-versed in municipal finances and has already taken on many of the duties and responsibilities of these roles.

- **NOW, THEREFORE, BE IT RESOLVED** that the City Council does hereby confirm City Manager LaPere's appointment of Pearl Tidwell as City Clerk-Treasurer.
