The City's liability and property pool insurance is up for renewal on April 24<sup>th</sup>. This is an annual policy that provides liability coverage for the city and property coverages and related services which are described more fully in the proposal documents. The annual premium for this year's coverage is \$128,024. When compared to last year's cost of \$132,920, it represents a premium decrease of \$4,896. The following exposure, rate and coverage limit adjustments are reflected in this renewal quote:

- MCCA rate change from \$220 per vehicle to \$100 per vehicle
- PIP rate change from \$51 per vehicle to \$80 per vehicle
- Three fewer automobiles (50 2020 to 47 2021)
- \$38,657 decrease in payroll (\$3,072,403 2020 to \$3,033,746 2021)
- \$808,257 decrease in agreed amount values (\$4,933,782 2020 to \$4,125,525 2021)
- \$176,433 decrease in total property values (\$32,790,548 2020 to \$32,614,155 2021)
- A slight rate increase

In addition, the MML Liability & Property Pool Board of Trustees voted to return another post-renewal dividend for members renewing in 2021. The City of Charlotte's portion of the dividend return is \$8,870. The City of Charlotte will receive this dividend in the month following payment of the 2021 renewal premium.

I have included the renewal documents for the policy and a resolution for approval for Council's review. Per Section 2-178, the purchase of insurance coverage does not require competitive bidding.
