WHEREAS, Mr. Baker has represented the residents of Charlotte with his service on the Charlotte City Council and Eaton County Board of Commissioners, being duly elected to multiple terms in each office by his fellow citizens; and

WHEREAS, Mr. Baker also represented the residents of Charlotte by holding the Office of Mayor of the City of Charlotte for 13 years, being elected six times by his fellow citizens.

**WHEREAS,** Section 7.7(B) of the City Charter requires Council approval for the expenditure of city funds; and

WHEREAS, the OCTOBER 14, 2021, Commercial Credit Card totaled \$2,588.40; and

WHEREAS, the OCTOBER 16, 2021, payroll totaled \$86,115.74; and

WHEREAS, the OCTOBER 25, 2021 insurance claims totaled \$790.28; and

> b. Consider Resolution 2021-152 Direct Administration to Distribute Essential Worker Premium Pay Under American Rescue Plan Act

## RESOLUTION NO. 2021-152 A RESOLUTION TO DIRECT ADMINISTRATION TO DISTRIBUTE ESSENTIAL WORKER PREMIUM PAY UNDER AMERICAN RESCUE PLAN ACT

WHEREAS, on March 11, 2021, President Biden signed the U.S. Senate amended H.R. 1319 (P.L. 117-2) known as the American Rescue Plan Act "ARPA"; and

WHEREAS, on May 10, 2021, the U.S. Treasury issued the Interim Final Rule to implement ARPA in Title 31, Part 35 of the Code of Federal Regulations ("CFR"; and

WHEREAS, under the Interim Final Rule, recipients may use Coronavirus State and Local Fiscal Recovery Funds "CSLFRF" to provide premium pay to eligible employees who performed essential work during the COVID-19 public health emergency. See CSLFRF Frequently Asked Questions No. 5.3; and

WHEREAS, on October 4, 2021 City Council allocated an amount not to exceed \$60,000 in total to provide premium pay to eligible employees who performed essential work as permitted by the Interim Final Rule, in accordance with City Charter, Ordinances, and other applicable agreements; and

WHEREAS, the city has identified personnel who serve on the frontlines and encountered the risks associated with exposure to COVID-19 first-hand when providing critical health and public safety services to the citizens in our community on a regular basis, during the pandemic; and

WHEREAS, those personnel are employees of the City in the Department of Public Work, Police Department, and Fire Department, many of which are represented by SEIU, POLC, and IAFF unions, respectively; and

WHEREAS, Treasury's Interim Final Rule emphasizes the need for recipients to prioritize premium pay for lower income workers. Premium pay that would increase a worker's total pay above 150% of the greater of the state or county average annual wage requires specific justification for how it responds to the needs of these workers. There are nine employees in the Police City Council Regular Meeting Minutes

Department and Department of Public Works that will exceed the base threshold. These employees were all required to report to work in-person, including performance of certain activities that put the employees at higher risk for exposure to COVID-19. These employees provided critical services to the health, safety, and well-being of the residents of Charlotte by maintaining the police force and the water and wastewater treatment operations of the community, and generally provided all essential city services remain functioning during the height of the pandemic; and

WHEREAS, those City Manager has received acceptance from IAFF and both POLC bargaining units, and preliminary acceptance from SEIU bargaining unit for the disbursements to be provided to eligible employees based upon hours worked during times in which persons were ordered to remain home during the COVID-19 pandemic;

**NOW, THEREFORE, BE IT RESOLVED** that the City Council does hereby authorize administration to disburse the allowable premium pay for eligible union and non-union employees of the City of Charlotte.

**BE IT FURTHER RESOLVED** that the City Council does hereby direct administration to disburse to the Volunteer Firefighters an additional stipend based upon call response as essential worker premium pay in recognition of their work on the front-line response during the pandemic.

c. Consider Resolution 2021-153 Authorize Circuit Court Filing by Attorney Hitch for Nuisance Complaint on Property at 221 E. Lawrence Ave.

# RESOLUTION NO. 2021-153 A RESOLUTION TO APPROVE THE CITY OF CHARLOTTE CIRCUIT COURT ACTION

WHEREAS, the City of Charlotte has received complaints regarding the junk vehicle storage that the property owner of 221 E Lawrence Avenue and upon investigation has discovered the building is being occupied for residential living space; and

WHEREAS, the property is Zoned B-3. In that Zone District, the storage of junk vehicles is prohibited, and the use of residential is not allowable by right nor as a conditional use; and

WHEREAS, the City has reviewed the available remedies to abate this nuisance and upon advice from the City Attorney seeks to request relief from the court system; and

WHEREAS, the City Attorney has drafted a complaint to file claim in Circuit Court to abate this nuisance and has provided a draft of that complaint for Council's review;

**THEREFORE, BE IT RESOLVED** that the City Council approves action by the City Attorney and Administration to file a complaint and take any other necessary legal actions to remedy this nuisance.

# A RESOLUTION TO AUTHORIZE PURCHASE OF A 2022 FORD F350 FOR THE FIRE DEPARTMENT

WHEREAS, the current Charlotte Fire Department Rural 311 was purchased in 2010 and runs out of the downtown station; and

WHEREAS, the vehicle has many mechanical issues and has become problematic and needs many costly repairs; and

**WHEREAS**, the Rural Fire Association approved the purchase 50/50 percent of a new 311 at their October 27, 2021 meeting; and

**WHEREAS**, replacement of 311 was budgeted in the FY 21/22 Budget in the amount of \$50,000; and

WHEREAS, Signature Ford summitted the lowest quote for a 2022 Ford F350 for the cost of \$35,430.00; and

**WHEREAS**, the 50/50 cost sharing with the Rural Fire Association will cost \$17,715.00 for the City of Charlotte and Rural each,

**THEREFORE, BE IT RESOLVED** That the City Council authorizes the purchase of a new 2022 Ford F350 from Signature Ford in the amount of \$35,340.00 with the cost being shared 50/50 with the Rural Fire Association.
