PUBLIC COMMENT:

Ryan Tetloff, a candidate running for District Court Judge, introduced himself and gave a brief overview of his career and accomplishments.

DISCUSSION ITEMS:

a. Presentation and discussion of City Road Improvements Council's objective was to gain knowledge about road improvement projects so they can make an informed decision about appropriating the ARPA funds towards road improvements within the City. This is in response to the results of a recent ARPA fund allocation survey indicating the public is in favor of road improvements

Gilson presented her outline used to determine which roads to fix beginning with an overview of the total miles of roads within the city classified as major, local or gravel. The rating of the condition of roads as determined by PASER (Pavement Surface Evaluation and Rating System). Determining which "fix" is required, i.e., preventative maintenance, rehabilitation or reconstruction. The objectives, preservation strategy, funding and costs and a map of City roads as classified by the PASER System.

It was noted that our City roads are classified as 72% as poor, 19% as fair and 9% as good condition according to PASER ratings. Amy has estimated over \$86 million in funding is needed to reconstruct roads rated in poor condition.

Other reports provided an explanation of sources of revenues and restrictions of use thereof; the history of road construction from 1995 to present; a list of major and local streets targeted for rehabilitation and estimated costs thereof. Reconstruction projects planned for 2023 include Hall/Washington/McClure; Island Road and the Safe Routes to School project.

Amy suggested the ARPA funds be appropriated to the reconstruction project planned for Hall/Washington/McClure.

Council would like to add the discussion on ARPA funding for road improvements to the July 18 Council meeting agenda.
