Re: Agreement with PotterVilla for website redesign proposal

#### **Background**

The City of Charlotte website was originally created internally and over the years, various users have added content which has resulted in reports of difficulty to use by end-users, as well as inefficiencies for updating content by staff. City Council identified the redesign of the website to modernize the interface and appearance, and to improve content delivery as a goal for this calendar year. City staff requested recommendations from other municipalities who have recently engaged in a similar project and contacted all the companies that were provided. We met with representatives from six companies who responded to our inquiry to discuss our project goals, and be given a demonstration of what their company could provide the city, including the user and staff interfaces. The larger, nation-wide companies tend to provide a templated product whereas the smaller, one-office companies offered a complete custom redesign.

Quotes were provided by the six companies, with a variety of pricing models. Because certain costs associated with the website will be ongoing and the pricing models varied how the expenses were allocated over time, the table below outlines the year one, year three, and year five costs for each option. In addition to cost, we considered the end-user experience for ease of navigation, aesthetics, and ability to locate information. We considered the staff/content management aspects of efficient workflows and user settings, and project timelines. We also considered any additional services or added value each company could offer.

We are recommending the lowest cost option from PotterVilla. The City's purchasing policy does not require sealed bids for professional services; additionally, their proposal is also under the \$5,000 threshold. PotterVilla is a local, Charlotte-based company who can provide a custom redesign of our website along with ongoing support, as-needed. We also received a positive recommendation when contacting their references. I have included a copy of their proposal for Council's review. As part of this project, they will also assist the City with registration of a dot-gov domain and perform necessary work to ensure persons who enter either dot-org or dot-gov

address will be directed to the City's site. This is part of a nation-wide effort to move municipal websites to dot-gov addresses to ensure end-users have confidence it is the official government site/content. Staff is looking into whether this aspect of the project may be eligible for grant funding to defray the related expenses.

It's extremely versatile and can create all kinds of different websites, but is also very simple to make updates and changes after the site is built. WordPress runs about 33% of websites on the internet and is what will power your new website.

#### **Custom Forms**

Gravity Forms is a premium plugin for WordPress that lets us create enhanced contact forms and landing pages. This will be helpful for the general build of the site, contact page, donations, etc., and gives us a lot of flexibility for connecting customers to you for the final sale.

#### **Divi Theme**

Divi is a market-leading framework theme for Wordpress from Elegant Themes—currently running several million websites across the internet. This level of usage helps ensure that your theme will be supported for a long time, and that extra care will be taken for backwards compatibility.

### Mega Menu

Mega Menu adds a higher degree of quality and customization from the standard Wordpress menu system. Add custom flyouts, fullwidth widgets or detailed information all within Mega Menu!

A Mega Menu is the name given to a large panel of content which is displayed below a menu item when the user clicks or hovers over the menu item. Mega Menus can contain sub menu items and Widgets.

## **Rebuild Timeline**

This quote is valid until September 15<sup>th</sup>, 2022. If you wish to accept this quote, please sign in the provided location and we will issue an invoice for the deposit. The quote is accepted when PotterVilla receives the funds of your deposit. After you approve the quote, here's how the development process moves through different stages:

- Development site Hosting setup and WordPress installation.
   This happens after your quote is accepted. It's the framework to build the rest of the site.
- 2. Design build, content & layout and plugin integration. With your input and approval for each sprint, we layout content and setup the look and feel of the site.

  Particularly after the first draft is complete, we like to schedule a meeting or call for review.
- 3. Final proofing and launch: We'll go back over the site with a fine-tooth comb, and then on your approval, launch the site!
- 4. Post launch updates and support 90 days.Any in-scope additions or changes to the site within 90 days of launch are covered!

We use a sprint-based development system, which means a lot of progress can happen on your site in a short period of time, but there may be short delays between those bursts of development. This is normal for the progress of your site.

Timeline for this website development project would take anywhere from 8-16 weeks depending on your response, acts of God, and other workloads. We are currently experiencing a higher volume of web development requests, which may extend this timeline additionally.

For the CharlotteMI.gov website development project, we are quoting 8 development sprints.

## Review, Feedback & Sprint System

As we progress through the development of the site, the first thing we'll send you is an initial draft of the homepage and a few of the sub-pages. These will be built based on the design direction as discussed and initial content you've provided.

After that initial draft build, we want you to go through the site and let us know what changes and additions need to be made. With a good change list from the first draft, we will complete another development sprint. Next, we'll have you review the 2<sup>nd</sup> draft, and help build a list of changes, updates, and new content for the next development sprint. These sprints are focused on content and design and are independent of backend feature development.

Once the site goes live, we'll include another series of post-launch sprints in the following 90 days after launching the site. We organize these sprints to streamline the development process, and maximize your opportunity to have input into the final product. Hopefully the whole process feels natural and seamless for you!
